If corrections need to be made to your FAFSA, the Financial Assistance Office will submit the changes on your behalf and will notify you of any changes by mail or email.

C.Verifying Taxable Income

If the student or the parent/stepparent filed or will file a 2022 IRS income tax return, verification of that income can be provided when the student and the parent/stepparent offer consent and approval for access, disclosure, and use of Federal Tax Information (FTI) on their FAFSA. If the FTI process is used, in most cases, no further documentation is needed to verify 2022 income information. If 2022 income tax return information is unavailable or FTI could not be used, the student and the parent/stepparent can provide a <u>signed</u> copy of their 2022 income tax return and <u>all</u> <u>applicable schedules</u>, or a 2022 IRS Tax Return Transcript.
